Sealed Bids for the construction of the **Wilcox County FY 2025 TIA Road Resurfacing Improvements - Cemetery Road** will be received, by the **Wilcox County Board of Commissioners**, at the **Wilcox County Board of Commissioners Office - 103 N. Broad Street, Abbeville, Georgia 31001**, until **11:00** local time on **January 20, 2026** at which time the Bids received will be publicly opened and read. The Project consists of **+/- 10,200 Tons of Asphalt Concrete 1.5" 12.5 mm Superpave, center line striping, stop bar striping and rumble strips.**

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Upon Issuing Office's receipt of payment, Bidding Documents will be sent via email or other means of electronic file distribution. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All permits required for the construction of this project are expected to be approved prior to the date of the bid opening.

Acquisition of property for easements, right of way, etc. is not expected to be required for this project.

This project is expected to be funded all or in part by the Georgia Department of Transportation, Transportation Investment Act (TIA) and Wilcox County Board of Commissioners funds.
