Sealed Bids for the construction of the **SEWER, STREET & STORM DRAINAGE IMPROVEMENTS, STILL WATERS ENG. PROJECT NO.: C1512.006** will be received, by the **City of Colquitt**, at the **Colquitt City Hall, 154 West Street, Colquitt, GA 39837**, until **10:30 am** local time on **March 30, 2022** at which time the Bids received will be publicly opened and read. The Project consists of **+/- 2,509 linear feet of 8" PVC Sewer Main, +/- 144 linear feet of 10" Cured In Place Piping, assorted 18"-36" storm drain piping, 2,900 linear feet of 24" roll over curb and gutter, +/- 12 drop inlets and +/- 195 Tons of 1" 9.5 mm Superpave Asphalt Resurfacing.**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

The date that the Bidding Documents are transmitted electronically by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The City of Colquitt, Georgia reserves the right to reject any or all bids including without limitation, the rights to reject any or all nonconforming, nonresponsive, unbalanced or conditional Bids; and to make an award in the best interest of the City of Colquitt.
