Sealed Bids for the construction of the **Water System Improvements to serve the Waycross-Ware Co. Commercial Park** will be received, by the **Waycross-Ware County Development Authority**, at **Waycross-Ware County Development Authority – 2855 Forest Drive, Waycross, GA 31503**, until **11:00 AM** local time on **Tuesday, August 8, 2023**, at which time the Bids received will be **publicly** opened and read. The Project consists of:

+/- 3,900 LF of 10 PVC Water Main including fittings, valves, fire hydrants, +/- 100 LF of 16" LF of 16" jack and bore steel casing along with all other appurtenances needed for a complete installation.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis with alternate bid items as indicated in the Bid Form.

The Issuing Office for the Bidding Documents is: **Still Waters Engineering, 130 Veterinary Way – Unit 2, Leesburg, GA 31763**. Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **8:30 AM – 5:00 P.M** and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents also may be examined at **Waycross-Ware County Development Authority**; during the regular business hours.

Bidding Documents may be obtained from the Issuing Office during the hours indicated above. Bidding Documents are available electronically (as portable document format (PDF files) for a non-refundable charge of **\$300.00**. Upon Issuing Office's receipt of payment, Bidding Documents will be sent via email or other means of electronic file distribution. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The Waycross-Ware County Development Authority reserves the right to reject any or all bids including without limitation, the rights to reject any or all nonconforming, nonresponsive, unbalanced or conditional Bids; and to make an award in the best interest of the Waycross-Ware County Development Authority.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All permits required for the construction of this project are expected to be approved by bid letting. NPDES permitting will be required for this project.

Acquisition of property for easements, right of way, etc. is not expected to be required for this project.

This project is expected to be funded all or in part by a OneGeorgia Equity Fund grant and Waycross-Ware County Development Authority funding. The construction contract will be subject to all applicable requirements of the respective funding agencies.
