Sealed Bids for the construction of the Colquitt County FY 2025 GTIB Road Resurfacing Improvements will be received, by the Colquitt County Board of Commissioners, at the Colquitt County Board of Commissioners Office - 101 East Central Avenue Moultrie, GA 31768, until 10:30 local time on February 19, 2026, at which time the Bids received will be publicly opened and read. The Project consists of +/- **12,695 Tons of Asphalt Concrete 1 .5" 12.5 mm Superpave**, +/- **8,615 Tons of Open Graded Interlayer (OGI)**, +/- **360 LF of 18" RCP**, +/- **480 LF of 24" RCP**, +/- **216 LF of 36" RCP**, +/- **80 LF of 48" RCP**, **Removal of Existing Storm Drainage Pipe and Headwalls, 34 Headwall Installations, center line striping, stop bar striping and traffic control.**

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **8:00 AM – 5:00 P.M.**, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Upon Issuing Office's receipt of payment, Bidding Documents will be sent via email or other means of electronic file distribution. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Bid security shall be furnished in accordance with the Instructions to Bidders.

All permits required for the construction of this project are expected to be approved prior to the date of the bid opening.

Acquisition of property for easements, right of way, etc. is not expected to be required for this project.

This project is expected to be funded all or in part by the Georgia Department of Transportation Georgia Transportation Infrastructure Bank (GTIB) and Colquitt County Board of Commissioners funds.
